As per the Indian Medical Council Act-1956 and the Dentists Act-1948, online applications are invited for **NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) - 2019 [NEET (UG) - 2019]** to be conducted by the National Testing Agency (NTA), for admission to MBBS / BDS Courses in India in Medical / Dental Colleges run with the approval of Medical Council of India / Dental Council of India under the Ministry of Health and Family Welfare, Government of India, except for the institutions established through an Act of Parliament i.e. AIIMS and JIPMER, Puducherry.

Admissions to all seats of MBBS / BDS courses will be done through NEET(UG) - 2019

PATTERN OF TEST: The NEET (UG) - 2019 shall consist of one paper containing 180 objective type questions (four options with single correct answer) from Physics, Chemistry and Biology (Botany & Zoology). This will be a single exam in pen-and-paper mode. The duration of paper would be 03 hours. The schedule of various events is as follows:
