- a) Candidate who have been allotted through centralized counseling by the **MCC of DGHS**, Govt. of India, New Delhi for admission to **BDS Degree Course** in the Deemed to be University for the academic year 2021-22, are advised to report and complete the admission process strictly within the date and time specified in the “Allotment Letter” issued by the **MCC of DGHS**.

- b) The candidate should report along with **original certificates and Demand Draft** for the prescribed tuition fee and other fees or UTR Number for **Electronic Fund Transfer through NEFT / RTGS** as specified herein below.
- c) i) Candidate without original certificates / documents shall **not** be allowed to take admission in the allotted Dental College.
- ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that “their original certificates are deposited with Institute / College / University” shall **not** be allowed to take admission in the allotted Dental College.
- d) Every student shall pay the tuition fee and other fee, as prescribed by the University, within the due date notified.
- e) Part payment of tuition fee and other fee are not permitted.
- f) No extension of time either for payment of fee or submission of original certificates will be entertained under any circumstances.
- g) At the time of admission, candidate should sign declaration / undertakings declaring that they shall abide by the rules and regulations of the University including Anti-Ragging regulations of the UGC / DCI and observe good conduct and behavior and that they are bound by the University rules on payment of fee / refund of fee.

03) MODE OF PAYMENT OF FEE:

a) TUITION FEE & OTHER FEE:

b) Details of Sponsorer under NRI Category:
