- a) Candidates who have been allotted through centralized counseling by the **MCC of DGHS, MHFW, Govt. of India, New Delhi** for admission to **BDS Degree Programme** in the Deemed to be University for the academic year 2022-23 are advised to report and complete the admission process strictly within the date and time specified in the **“Allotment Letter”** issued by the **MCC of DGHS**.

- b) The candidates should report along with **original certificates and Demand Draft or UTR** Number for **Electronic Fund Transfer through NEFT / RTGS** for the prescribed tuition fee and other fees as specified herein below.

- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Dental College.
- ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that “their original certificates are deposited with Institute / College / University” shall **not** be allowed to take admission in the allotted Dental College.

- b) **Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the DCI and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and not found medically fit, will not be admitted to the course of study to which they are allotted by the **MCC of DGHS**. If it is found at a later stage, that the candidate has given false information / forged certificates or concealed material information, his / her admission will be cancelled without any notice.
- c) Students will be governed by all the University rules including rules for refund fee, disciplinary rules and hostel rules and UGC / DCI Regulations for Curbing the Menace of Ragging etc.
